## Report on Night Walk - Banyule Flats 8th September

WCS organised a night walk as part of the Spring Outdoors program. We had about 30 participants and met at the Swamp viewing area at twilight to watch the birds coming in. As it began to get dark and the temperature dropped, we split into two groups going in opposite directions on the track around the Banyule Billabong. One group was led by Meg and Tom from the Banyule Bush crew. I went with the other group led by Lincoln Kern from Practical Ecology. On the way out we stopped and admired some of the pre-European river redgums with their hollows that are used by native wildlife. Not far into our walk we spotted a large bird on a straggly eucalypt. Looking closer we saw the large eyes and unmistakable chevron pattern on its chest that told us it was a Powerful Owl. It sat quietly as Lincoln explained how Powerful Owls can do well in pockets bush on the edge of suburbia that support good numbers of possums. The owl then took off into some nearby bush, giving us a good look at its large broad wings, strong legs and large talons. Completing our lap around the billabong, we saw

some Tawny
Frogmouths (see photo)
and Ringtail Possums.
The other groups saw a
possum but
unfortunately missed the
owl. Banyule Flats is a
great place to explore at
night and we will
continue to run these
walks. Many thanks to
leaders Meg, Tom and
Lincoln.

#### NORTH EAST LINK update

Warringal Members joined with Friends of Banyule to attend two weekends of North East Link Drop in Information Sessions at Watsonia RSL (15-16/9) and Bulleen Yarra Junior Football League club house Bulleen (22-23/9). We used our clear-cut and unambiguous maps of the project area to discuss the project impacts and handed out our recently developed flyer (attached) and the Friends of the Earth Get on Board flyer to promote public transport options as a feasible, sustainable and healthier alternative to the damaging NEL proposal. At these and other events NEL Authority were promoting their latest design drawings and artists impressions which they will be taking to the State Election on 24th November. #### **Habitat Stepping Stones**

This is a national non-profit program which promotes the provision of habitat for wildlife which is important for supporting fauna and retaining ecological diversity, especially if it involves indige-



nous planting. We love the concept of individual homes creating a stepping stones which build into a wildlife corridor. Participants in the program are asked to add three elements of food, water, and shelter to their garden or balcony to create a wildlife-friendly environment. You can then choose to 'register' your property and receive a plaque to promote the scheme. More information:

#### 69 & 71 Banyule Road, Rosanna- P1668/2018-P290/2018

This is a contentious 33 unit development proposed alongside River Gum Park on the old on the site of Viewbank House and a large residential allotment. The developers have chosen to take this application direct to VCAT as they hadn't had a response from Council with the statutory time limit. A number of residents, including Warringal members are opposed to this over development proposal due to the loss of significant trees, including river Red Gums, the excessive over development of the site which results in bulkiness, inadequate boundary set backs and visual intrusion. A compulsory conference has been scheduled for the 20th November, while the actual case if it proceeds will be heard over three days from Wednesday 6th February 2019.

After an introduction from the Mayor, Simon di Pasquale, participants engaged in lively discussions around four topics where, typically, councils can influence change – transport, energy, building and waste. We are now waiting for a follow-up from all the ideas suggested.

#### Yarra River Protection Act (YRPA)

On 13 October Environmental Justice Australia and the Yarra Riverkeeper Association (YRKA) jointly hosted a one-day 'Community Roundtable' on the Yarra Strategic Plan. There were about 20 partici-

pants of Friends groups from along the river corridor including 4 local groups: Warringal Conservation Society, Friends of Banyule, Riverlands Conservation Society and Friends of the Yarra Valley Parks. We heard briefings on the implementation and interpretation of the Act, and workshopped ideas for inclusion in the Yarra Strategic Plan for which Melbourne Water is the lead agency. This was a valuable opportunity to share ideas and build community network and discuss strategies for future input to the process of developing the Plan. As the meeting was held at the Old Shire Offices we ended the day with a tour of Banyule Flats to showcase the revegetation work and its positive impact on wildlife, and discussed the potential impact of the NEL and rewatering of the Banyule Billabong. #### **Threatened Ducks and Hunting**

Warringal Conservation Society recently made a submission to the Senate Inquiry into Australia's threatened species extinction crisis. As we pointed out, the list of Australia's threatened species is continuing to grow, and the threats to native species are increasing. Recreational hunting is one of the well known threats to the survival of native species all over the world.

Australia's Blue-billed Duck and Freckled Duck are not legal target species for duck shooters; yet many are shot and killed in the annual hunting season in Victoria. In 2017, on only a handful of Victoria's thousands of wetlands, rescuers recovered 296 protected threatened species that had been shot and left to die by recreational hunters. These included 145 dead/wounded Freckled Duck and 38 dead/wounded Blue- billed Duck. These species are unique to Australia.

This year, despite all the media evidence of continued illegal activity by Victorian duck hunters, the Game Management Authority, which is funded by Australian tax payers, failed to gain a single prosecution. The Authority now has a new CEO. But what is really needed is for the law to be changed and the threat removed that is currently posed by hunting to

the survival of Australia's unique threatened species.

It is tourism that will replace duck bunting. Devel

It is tourism that will replace duck hunting. Development of a vibrant nature-based wetlands tourism industry, including Koorie history and heritage, would attract some of the millions of worldwide birdwatchers as well as a multitude of Chinese visitors, and generate real financial returns for regional towns. To its credit, the Victorian Government is helping small towns develop nature-based tourism.

The annual eastern Australian aerial waterbird and wetland survey is in its 36th year and is now underway. The project provides critical information on the health of waterbird populations and wetlands throughout eastern Australia. Its blog can be followed at: https://bit.ly/2xVrPBw.

The Victorian election this November is critical for helping the ducks. Three minor political parties have said they would work to ban duck hunting if elected. Recreational duck hunting was banned in other States by Labor Premiers - Carmen Lawrence in WA (1990), Bob Carr in NSW (1995) and Peter Beattie in QLD (2005).

- Monitoring to detect the trajectory of species populations within the study area; assess effectiveness of management actions and facilitate community engagement

#### President's Annual Report from Committee October 4th 20018

**Conservation** We have continued our foundation work to restore and maintain Banyule Flats and Warringal Parklands. Guided by Banyule Bush Crew, we have had 8 monthly Sunday morning plantings/weedings. The results are testament to 48 years of member participation.

In November 2017 the Sunday planters and WCS members were treated to an outing to Westgate Park, and this was a very successful and interesting day.

We have advocated to keep the tranquillity of Banyule Flats by opposing the redevelopment of Banyule House as a reception and function centre. Michelle Giovas did a sterling job to highlight potential environmental impacts of the application at VCAT. And Jane Crone strongly objected on behalf of the heritage values of the site. With avid and professional opposition from Banyule Estate Residents Group and their representatives, VCAT upheld the application to everyone's great relief.

Also, on environmental grounds we have objected to the development at 69 & 71 Banyule Rd. This application has been rejected by Banyule Council and we are yet to hear whether it will go to VCAT.

**Membership** Our membership stays fairly steady with 69 paid-up members, 28 life members, and 6 Hon. life members. We were very saddened by the recent deaths of 2 of our most longstanding and dedicated members, Brian Fleming and Beryl Jarman. We noted the passing of 3 other members. But we have welcomed several new members and hope they will enjoy their participation.

Warringal Prize This year's \$500 prize for top marks in first year Bachelor of Science (Wildlife and Conservation Biology) at La Trobe was presented by James Deane to Suzanne Moss in September. Thanks to everyone who has contributed through their donations to encouraging a young person towards a career in environmental science.

**Education** We hope that all monthly attendees to meetings have enjoyed our expert speakers. We have had some splendid presentations this year: on biomimicry, the Yarra River, the ecology of Banyule Flats, natural history as applied to local history, our native fish, the benefit of urban trees, and about native bees. We thank all speakers.

We produced a flyer showing the significant species of Banyule. And we followed that with an excellent and popular map of Banyule Flats. After two years of hard work we are about to witness the placement of two interpretive signs, one on birds at the Banyule Swamp, and the other showing the significance of

We have continued our foundation wetlands beside the Main Yarra Trail. Thanks to Bendigo Bank and Banyule City Council for grants for these projects, and thanks also to all who contributed their time and thoughts.

Advocacy This year we have continued to advocate on behalf of the Yarra, by attending forums, meetings, and writing submissions in relation to the Yarra Strategic Plan. We successfully recommended that Banyule Flats and Warringal Parklands be included in the scope of this Plan.

We have given our voice to stand up for banning live shipments, banning opera house nets, for saving threatened species midst the faunal extinction crisis, and for the protection of old growth foressts in Gippsland. We have met with local, State and Federal members of Parliament to advocate on environmental issues.

However, our focus in 2017-8 has been advocating on behalf of citizens and the environment against the North East Link. All our work has been minuted in the monthly committee reports and written up in the newsletter, and no one wants to listen here to a lengthy blow by blow account. Suffice at this point to say that the committee has lobbied State politicians, spoken at and attended NELA and council forums, sat on Community Liaison groups, attended community drop-in sessions where we have distributed handouts and gleaned information, liaised with other local friends groups, had a marquee at the annual Kids Arty Farty Festival in March where many stopped with their NEL concerns, and jumped on board Friends of The Earth's Get On Board campaign(Sustainable Cities). Our general exhaustion would be more bearable if we could have diverted the ship, but there is still an election and an Environment Effects Statement for the Labor Government to negotiate. We shall continue to push for the best outcomes for our beautiful Flats and Banyule.

We should like particularly to thank Dennis O'Connell and Friends of Banyule for their partnership in the NEL campaign.
